



## **Award for best communication on Applications in Health Sciences by a junior researcher**

### **RULES**

#### **1. Call**

---

The Galician Society for the Advancement of Statistics and Operations Research (SGAPEIO) and the Portuguese Statistical Society (SPE) call an award for best communication on Applications in Health Sciences among those presented at the II Galician-Portuguese Meeting of Biometry by a young researcher.

This award is sponsored by the Galician Directorate for Public Health, Galician Health Authority (*Dirección Xeral de Saúde Pública, Consellería de Sanidade, Xunta de Galicia*).

#### **2. Participants**

---

The requirements to apply for the award are:

- 2.1. Fulfill the following conditions to be a young researcher:
  - Not having 35 years on June 30, 2016, with certified copies of ID or similar document.
  - Do not hold a doctorate and be enrolled in a doctoral program during the academic year 2015/16, credited with the copy of the receipt for registration.
  - Having obtained the first doctorate after June 30, 2011, with certified copies of the degree.
- 2.2. Be the first author of the communication.
- 2.3. Enroll in the meeting and orally present communication in a special session for communications applying for the award.
- 2.4. The work to be presented to the award must be original (can not be published before June 30, 2016 in a scientific journal).
- 2.5. There is no limitation of communications presented by the same person. In the event that a person presents several works, the theme must be different.

### 3. Registration

---

To apply the award for best communication on Applications in Health Sciences, among those presented at the II Galician-Portuguese Meeting of Biometry, in addition to the requirements of Section 2, one must send a message to the e-mail address [bioapp2016@sgapeio.es](mailto:bioapp2016@sgapeio.es) including subject “Award BIOAPP2016-Health Sciences” and indicating the following information:

- Full name of the first author of the communication.
- The communication title.
- Condition that meets the author to be a young researcher described in section 2.1. It is necessary to send the message with a document certifying.

### 4. Jury and evaluation of communications

---

The jury will consist of five people chosen among the Scientific Committee of the II Galician-Portuguese Meeting of Biometry. Co-authors of the work, the tutors or directors, and people who have a contractual relationship with the candidates can not be part of the jury. In case the members of the Scientific Committee are not enough for some of the incompatibilities described, members of the Organizing Committee may be part of the jury.

The jury evaluates communications considering the work submitted to the meeting, as well as the presentation made during the special session of communications for candidates for the award.

The jury's decision is final and awards cannot be assigned by this proposal.

### 5. Award

---

The first author of the award-winning communication will receive a cash award of 500€. Likewise, all the authors of the communication will receive a certificate attesting to the award.
